REPUBLIC OF GHANA

The Government of Ghana acting through the Ministry of Sanitation and Water Resources (MSWR) is currently implementing the GAMA Sanitation and Water Project (GAMA S&W Project) with support from the International Development Agency (IDA) of the World Bank.

The objective of the Project is to increase access to improved sanitation and water supply in GAMA with emphasis on low income communities and strengthen management of environmental sanitation in the GAMA. As part of the strategies to achieving enhanced environmental sanitation and to alleviate flood risks in GAMA, construction of culvert and drainage works has been proposed to be undertaken at Gbawe Onyinase in the Ga South Municipal Assembly. As required by the World Bank Involuntary Resettlement Policy (OP) 4.12, and the Government of Ghana, an Abbreviated Resettlement Action Plan (ARAP) has been prepared to address potential impacts of the proposed construction on Project Affected Persons.

The ARAP outlines the applicable legal and administrative framework for compensation and resettlement related issues; baseline characteristics of the project area, potential negative impacts, census and socio-economic condition of Project Affected Persons, eligibility criteria and entitlements, consultations; grievance redress process, implementation plan among others.
